What Is *Contemporary Ophthalmology*?

Contemporary Ophthalmology is a bi-weekly CME publication for ophthalmology. The 6- to 8-page newsletter provides in-depth coverage of current topics to keep physicians up to date on new developments, procedures, and advances in ophthalmology.

How Should Manuscripts Be Prepared?

- Prepare manuscripts, including tables and figure legends, using commercially available word-processing software. Provide references, tables, and figure legends after the text. The word count for the manuscript is 4000 words, not including figures or tables.
- Include a separate title page with the name, address, e-mail address, and telephone and fax numbers of the author responsible for correspondence with the editorial office and review of page proofs.
- Begin each article with three learning objectives. Provide 10 Continuing Medical Education questions at the end of the document (see Continuing Medical Education Quiz, below).
- Cite references, numbered consecutively through the text, and format according to AMA/Index Medicus style. Please do not use the endnote or footnote functions in Microsoft Word to formulate the reference list. In general, manuscripts should not contain more than 30 references. Because of space limitations, try to limit references to critical sources.
- Submit manuscripts and figures either electronically (via e-mail) or mailed, with accompanying discs, to the Editor.
- Make sure to obtain permission to reproduce any figures or tables that originally appeared in other sources. Submit written permission from the copyright holder with the manuscript.
- Accepted articles will be processed electronically. In addition to a word-processing file that contains all final text, tables, and figure legends to be published, authors should submit figures as separate color or black and white, 5x7 glossies or as JPEG or TIF files. Authors will receive page proofs to review in Adobe PDF format (see below).
- If you have discussed unlabeled/investigational uses of a commercial product in your article, please indicate this in the following format:

The use of _____ [drug/therapy] has not been approved by the US Food and Drug Administration for the treatment of _____ [disorder].

How Should the Continuing Medical Education Quiz Be Prepared?

Each article will be published with a Continuing Medical Education quiz consisting of 10 multiple-choice and/or true-false questions. Authors should provide these questions and answers with the finished manuscript. Each question must have only one correct answer, and each answer should be clearly supported by the text. You may include one extra illustration for use in the question page and frame a question about it. Avoid statistical questions try to stick to differential points or basic concepts. Do not use two choices that are clearly mutually exclusive. Make options roughly the same length. (At least, do not make the correct answer visibly different from the distracters.)

Are Author Disclosure Forms Necessary?

All authors must sign an Author Disclosure form. This form will be sent from the Editor and must be returned by fax to (617) 621-2953 prior to publication. Articles will not be published without this documentation.

What About Copyright Assignment?

All authors must sign a Copyright Assignment form. This form will be sent from the Editor and must be returned by fax to (617) 621-2953 prior to publication. Articles will not be published without this documentation.

How Does the Production Process Work?

The publisher via e-mail will send page proofs for review to the corresponding author. (All articles must be accompanied by an e-mail address for the corresponding author; see Preparation of Manuscripts, above.) The page proofs will be sent in Adobe PDF format containing all text and artwork. The corresponding author must review the proofs, answer editorial queries, and return corrections by fax to the publisher (610-626-6175) within 72 hours of receipt.

How Are Honoraria Paid?

An honorarium in the form of Lippincott Williams & Wilkins books and/or CDs will be paid for each article published in *Contemporary Ophthalmology*. An Author Payment form will be sent from the Editor and should be returned by fax to (617) 621-2953 at the author's convenience. In addition, 10 copies of the article and a complimentary one-year electronic subscription to the publication will be provided to one author of each article.
