What Is *Contemporary Ophthalmology*?

Contemporary Ophthalmology is a twice-monthly publication for continuing education in ophthalmology.

How Should Manuscripts Be Prepared?

- **Please refer to the accompanying documents for a more detailed discussion of the responsibilities and obligations of authors providing CME lessons.**
- Begin each article with one or more learning objectives that reflect the desired outcomes for learners in terms of competence or performance (see the Faculty Responsibilities and Obligations document for more detail).
- In your introduction, please describe the scope of the problem or issue being addressed and identify for learners how they can apply the educational activity to their practice. Mention any audience-specific competencies that your activity will address.
- Your content and recommendations should be evidence based and fair balanced, using generic names of products or devices (if any) whenever possible, and identifying any off-label or investigational uses of drugs or devices. Consider including case studies or thought-provoking questions throughout the article to engage the learner. Identify barriers learners may encounter in applying the article to their practice, and include strategies for overcoming them. Include tables, figures, algorithms, or other tools that support your content and that learners can use in practice.
- Cite references, numbered consecutively throughout the text, and format according to AMA/Index Medicus style. Please do not use the endnote or footnote functions in Microsoft Word to formulate the reference list. In general, manuscripts should not contain more than 30 references, and will usually contain less. Because of space limitations, try to limit references to critical sources. References may specifically support a statement in your lesson or may simply be a list of “Suggested Readings” at the end of the lesson provided that information and recommendations are supported by evidence contained in the Readings.
- In your conclusion, please summarize the patient care recommendations and strategies that learners can incorporate into their practice. If the word count permits, include a table of “practice pearls” summarizing the recommendations.
- Provide 10 questions at the end of the document that assess attainment of the learning objectives. Questions should measure competence or performance rather than knowledge recall. Mini case studies may be particularly effective for assessing competence (see the Faculty Responsibilities and Obligations document for more detail).
- Submit manuscripts and figures electronically (via e-mail) to the Associate Editor; the target word count for the manuscript is 4000 words, not including figures and tables.
- Authors are required to obtain permission to reproduce any figures or tables that originally appeared in other sources. Submit written permission from the copyright holder with the manuscript. If the copyright holder charges a fee for permission to reprint, it is the responsibility of the author to pay the fee.
- Accepted articles will be processed electronically. In addition to a word-processing file that contains all final text, tables, and figure legends to be published, authors should submit figures as separate JPEG or TIF files. Authors will receive page proofs to review in Adobe PDF format (see below).

What About Copyright Assignment?

All authors must sign a Copyright Assignment form prior to publication. This form will be sent from the editorial office and must be returned prior to publication. Articles will not be published without this documentation.

How Does the Production Process Work?

The publisher will send page proofs via e-mail for review to the corresponding author. (All articles must be accompanied by an e-mail address for the corresponding author; see Preparation of Manuscripts, above.) The page proofs will be sent in Adobe PDF format containing all text and artwork. The corresponding author must review the proofs, answer editorial and CME-related queries, and return corrections by fax to the publisher (206-600-5058) within 72 hours of receipt. How Are Honoraria Paid?

An honorarium will be paid for each article published in *Contemporary Ophthalmology*. An Author Payment form will be sent from the publisher with page proofs, to be returned with page corrections. Payments may be paid to one author or split among authors. In addition, 10 copies of the article and a complimentary one-year electronic subscription to the publication will be provided to one author of each article.
